## Severn River Restoration – Is It Working?

Just how successful have been efforts to restore Severn River creeks that have been heavily damaged by stormwater, sediment and nutrient pollution?

The public is invited to find out during the monthly meeting of the Severn River Association (SRA). The meeting begins at 7 pm on Tuesday, September 17, at Arlington Echo in Millersville.

The meeting will feature two experts in the field of ecosystem restoration who are driving forces behind projects to revive water quality and stem the flow of stormwater that threatens the creeks on the western shore of the Severn River.

Speaking will be Sara Caldes, Program Manager with the Severn RiverKeeper Program, and Keith Underwood of Underwood and Associates.

Our guests will discuss the effectiveness of regenerative stream project they started two years ago to repair stormwater damage to Clements Creek.
